

# MONARCHS IN MEXICO 2011 – TRIP DETAILS

## COST OF THE TRIP

The fee for this trip is: \$1500.00 per person in a double occupancy room OR  
\$1800.00 per person in a single occupancy room

This fee includes **accommodations for seven nights; all meals** including non-alcoholic beverages (starting with dinner on day 1 and ending with dinner on day 7); **all ground transportation\***; **entry fees** to sites included in the itinerary; **horseback riding** at the Cerro Pelon and Sierra Chincua monarch sanctuaries; and **tips** for restaurant staff, horsemen, hotel porters and housekeeping staff. Also included in this package are up to two pre-trip meetings, one post-trip meeting (see dates and details below) and a set of **photo CDs** compiled from photos submitted by participants in the week that you traveled.

Items not included in this fee are airfare, trip insurance, a tip for our bus driver, alcoholic beverages, and souvenirs. Excluding trip insurance and airfare, which can vary greatly depending on your point of origin and the timing of your ticket purchase, most of our previous trip participants have found that about \$300.00 US dollars (converted to MX pesos) will cover the expenses that are not included in the trip fee. However, if you do not plan to purchase many souvenirs or alcoholic beverages, you could bring less.

You are responsible for making your own round trip flight arrangements to the Morelia, Michoacán, Mexico (MLM) airport. We highly recommend you make your flight arrangements after November 15, 2010 to ensure that your trip week has adequately filled.

\*Please note we are not able to provide transportation to and from the airport in Mexico City nor can we accommodate arrival and departure times at the Morelia airport other than those noted in the itinerary.

Reservations are accepted and confirmed after we receive a signed application form and \$750 deposit for each trip participant. Applications with deposits will be accepted on a first come, first serve basis until spaces are filled. Each trip is limited to sixteen participants. The balance of the trip fee must be received by December 31, 2010.

## MEXICO BOOK PROJECT – OPTIONAL DONATION

Over the past eight years Monarchs Across Georgia and the Environmental Education Alliance of Georgia have worked with various book companies to provide elementary-level books written in Spanish to students living in the rural areas surrounding the monarch overwintering sanctuaries in Mexico. If desired, you may choose to make a tax-deductible donation to help bring much-needed educational materials to these children.

As a reference, books generally cost about \$8.00 each in American currency. In appreciation, a bookplate with your name (or name designated by you) will be attached to the inside cover of each book donated. Donors may also be recognized on the Monarchs Across Georgia website. ## **DOCUMENTS REQUIRED FOR TRAVEL TO MEXICO**

All persons including U.S. citizens traveling by air between the United States and Mexico will be required to present a valid U.S. Passport Book. Please note that the new U.S. Passport Card cannot be used for international air travel. To obtain or renew a U.S. Passport Book, refer to the U.S. Department of State website at [http://travel.state.gov/passport/passport\\_1738.html](http://travel.state.gov/passport/passport_1738.html). The time required to process a Passport Book is approximately four weeks although this can be expedited for an additional fee.

You will be issued a Tourist Card to complete on the airplane as you enter Mexico. **Keep this card safe with your Passport Book at all times. You will need to present it when you leave the country.** The cost of replacement tourist card is at least \$50.00 US dollars.

## **HEALTH PRECAUTIONS**

***Please read this section carefully.***

The monarch butterfly colonies are usually located near an elevation of 10,000 feet. Depending on where the colony forms on the mountainside, the hike can be strenuous for people not used to this altitude. If you have any doubts about your health at such altitudes, we strongly suggest that you consult your physician first.

Both in order to experience the ambience and because there is often no alternative, we will be walking every day. The distances may be as short as a few city blocks to as long as four miles. You should be able to walk several miles comfortably to take full advantage of the opportunities available. Walking on inclines or hills will best prepare you for this trip.

**Please do not apply for this trip if you have medical conditions that will deter you from participating fully. If you have asthma or any other problems that will be aggravated by dust, 10,000 foot elevations or strenuous exercise, this trip may not be appropriate for you.**

No vaccinations are required to enter Mexico. The Center for Disease Control and Prevention (CDC) recommends immunization against Hepatitis A. Visit the CDC website on Traveler's Health at <http://wwwnc.cdc.gov/travel/destinations/mexico.aspx> for the latest information on potential health hazards in Mexico, especially if you choose to extend your stay to visit areas that are not on our itinerary.

**To avoid traveler's diarrhea, follow these common-sense rules from the CDC:**

- Wash your hands often with soap and water, especially before eating. If soap and water are not available, use an alcohol-based hand gel (with at least 60% alcohol).
- Drink only bottled or boiled water, or carbonated (bubbly) drinks in cans or bottles.
- Avoid tap water, fountain drinks, and ice cubes.
- Do not eat food purchased from street vendors.
- Make sure food is fully cooked.
- Avoid dairy products, unless you know they have been pasteurized.

Bottled water is available in all of the rooms of our hotels as well as at every meal. We will also have a 5-gallon container of purified water with a pump on the bus to refill your water bottles.

If traveler's diarrhea (TD) does occur, the prescription drug, ciprofloxacin, is almost an overnight cure. Imodium or Kaopectate can help relieve symptoms. Drinking and eating cautiously is usually sufficient to avoid the problem. **Please consult your doctor. Obtain a prescription for TD and bring your medication with you!**

Please also remember to bring your other prescriptions and over-the-counter medications, such as those for motion sickness and allergies. Purchasing even simple over-the-counter medications can be difficult in rural Mexico. If you are prone to respiratory infections, you may also want to consider asking your doctor for a prescription and bringing this medication with you.

### **ADDITIONAL INFORMATION**

Additional information including a map of the area that we will visit, hotel contact information, a suggested packing list, etc. will be provided either when you send in your application and payment or at our first pre-trip meeting.

Up to two pre-trip meetings and one post-trip meeting are scheduled to better prepare you for the trip, to answer your questions and to facilitate the educational/ service opportunities that are available. Pre-trip meetings are held at Confederate Hall in Stone Mountain Park, Stone Mountain, GA. A reminder and directions will be sent to trip applicants prior to the meetings. The location of the post-trip meeting in the Atlanta, Georgia area will be announced at a later date.

(This meeting is designed for everyone participating in the trip.)
- Saturday, January 8, 2011, 1:00 – 3:00 p.m.  
(This meeting is designed for teachers seeking professional learning units - PLUs.)
- Saturday, March 26, 2011, 6:00 – 9:00 p.m.

Five PLUs are available for Georgia certified teachers participating in this trip. In addition to a signed "prior approval form" from your school or district, attendance at the January 9 pre-trip meeting is required for PLU credit.

Out-of-state participants are not expected to attend meetings. If you cannot attend, all information from the meetings will be e-mailed or sent to you via USPS in a timely fashion.
